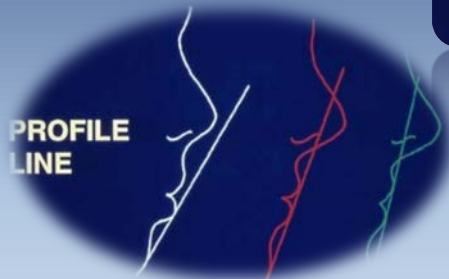
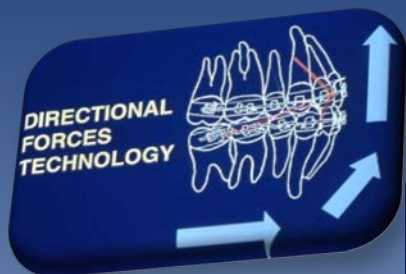

## Jim Vaden TWEED FOUNDATION AND TWEED STUDY COURSE HISTORY

The Charles H. Tweed Foundation has a long and colorful history. Its history is important to the specialty of orthodontics and to the future of the specialty. This presentation will explain the relevance of this colorful history to the future of the specialty.

## Herb Klontz DIFFERENTIAL DIAGNOSIS AND GUIDELINE FUNDAMENTALS

The diagnostic parameters that lead the clinician to the best treatment plan choice for each type of malocclusion will be explained. The first premolar extraction pattern is ideal for the correction of the crowded and/or protruded malocclusion. Force systems for this treatment plan will be shown. Many class II malocclusions can be best corrected with the removal of the maxillary first and mandibular second premolars. The force systems that have been developed to treat the maxillary first/mandibular second premolar extraction pattern will be presented and explained.

Balance and harmony of the face is a fundamental goal of orthodontic treatment. This presentation will present the prerequisites for balance and harmony of the face by illustrating diagnosis and treatment planning concepts that will ensure facial balance and harmony.

## Jim Vaden GOALS AND CONCEPTS REVISITED

The fundamentals of orthodontics are extremely important. Fundamentals must be used during treatment planning and during the treatment of each malocclusion. This presentation will review the fundamentals that are so important to the specialty of orthodontics and to every orthodontic patient.

## Herb Klontz MYSTERY CASE REPORTS

Jim Vaden

Some malocclusions do not “fit” the normal treatment planning protocol. They might be amenable to treatment with several different treatment plans. The development of the treatment plan is therefore an issue. Several of these types of malocclusions will be presented. Audience participation will be encouraged.

## Jim Vaden LONG TERM RETENTION

The treatment plan for each patient, and the subsequent treatment, must be designed with long term retention as the goal. This presentation will discuss the retention literature as well as the treatment planning concepts that lead to stability.

# 講師略歴

## Herbert Klontz

Herbert Klontz has been a private practitioner in Orthodontics from 1962 to the present. He is also a Professor in the Department of Orthodontics at the Oklahoma Health and Science Center. Dr. Klontz has been on the teaching staff of the Charles H. Tweed Study Course since 1967. He became the Tweed Study Course Coordinator in 1976 and the Director in 1983. For over fifty years Herb has lectured and taught the Tweed-Merrifield Philosophy and Force Systems throughout the world.

## James L. Vaden

James L. Vaden has been a private practitioner in Cookeville, Tennessee since 1972. During his professional career, he has been privileged to serve as a Director of the American Board of Orthodontics, as a Commissioner for orthodontics for the Commission on Dental Accreditation, and as a member of various AAO standing committees and councils. In addition to his private practice, Jim has been a clinical professor at the University of Tennessee since 1980. He served as the Professor and Chairman of the Department of Orthodontics at the University of Tennessee from 1999 until 2010. He also served as an adjunct clinical professor from 1991 to 1999 in the Department of Orthodontics and Pediatric Dentistry at the University of Michigan. Dr. Vaden has been active with the Charles Tweed Foundation and the Tweed Study Course since 1976. He has been an Assistant Course Director and is currently a Co-Director of the Tweed Study Course with Herb Klontz.
